I agree to defend, hold harmless and indemnify The Nature Conservancy and its employees, officers and agents, and the Chicago Park District, its commissioners, officials, officers, employees, other volunteers or agents as to any claim that I and/or my minor child/ward, or anyone on my and/or my minor child/ward's behalf, may seek to assert arising from volunteer participation with the Chicago Park District. I relinquish, fully release and forever discharge the Chicago Park District, its commissioners, officers, agents and employees as well as The Nature Conservancy and its employees, officers and agents, from any and all claims that I, my minor child/ward, or any representative on behalf of my minor child's/ward's behalf, may have or that may accrue or arise out of my child's/ward's participation in the program.

I further understand that I and/or my minor child/ward shall not be entitled to participate in any of the Chicago Park District benefits, including without limitation any health or retirement plans. The Chicago Park District shall not be liable for taxes, Worker's Compensation, unemployment insurance, employers' liability, employer's FICA, social security, withholding tax, or other taxes or withholding for or on behalf of me and/or my minor child/ward.
